## **INVEST Spending**

#### Where do my INVEST dollars go?

**Classroom & Educational Support**. This includes technology purchases and upgrades, educational materials and training, specialized instructional support, arts, music and supplies.

**Student, Teacher & Family Activities.** This is allotted for awards, club scholarships, PTO events such at the Carnival, Motown, Matador Madness, etc. This also includes student, community and teacher appreciation events.



PTO Operations. PTO Operations is comprised of office equipment, financial fees, hospitality, insurance, bonding & licensing, compliance, and supplies.



**Communications.** This covers our online directories, email communication software, prospective parent open houses, feeder school supplies , shirts & signs, PR & marketing.

**Principal's Discretionary Fund.** This fund helps with faculty and staff team building activities, upgrades to front office, celebrating staff and various other school operations.

#### Matador Fund

- The Matador Fund is intended as an additional way to support the needs of teachers, teaching teams, clubs and athletics. We recognize that not all needs can be known at the time the PTO puts its budget together, so it creates an additional funding mechanism for non-budgeted items.
- The Matador Fund committee will be made up of the Matador Fund Committee Chair, Principal, PTO President, PTO Treasurer and at least one additional member not currently serving in a PTO Board capacity.
